Please refer letter No. MMU/R/2012/984, dated 03.01.2012 received from the Registrar Maharishi Markandeshwar University, Mullana-Ambala, Haryana with regard to transfer of recognition of MBBS degree conferred on students trained in M.M. Institute of Medical Sciences & Research, Mullana (Ambala) from Kurukshetra University, Kurukshetra to Maharishi Markandeshwar University, Mullana (Ambala). Copy of letter is enclosed herewith for your ready reference.

In this connection, this is to inform that the matter has been considered by the Board of Governors at their meeting held on 4<sup>th</sup> & 5<sup>th</sup> February, 2012. The Board of Governors noted that as per practice and procedure adopted, such cases were processed as per Executive Committee decision dated June, 1988 which reads as under:-

"No inspection is required where there is change of name and change of affiliation of the University or the college whose medical qualification are already recognized and included in the 1<sup>st</sup> schedule to the IMC Act, 1956 unless the Executive Committee decided otherwise."

The Board of Governors therefore decided to approve the proposal for transfer of recognition of MBBS degree conferred on students trained in M.M. Institute of Medical Sciences & Research, Mullana (Ambala) from Kurukshetra University, Kurukshetra to Maharishi Markandeshwar University, Mullana (Ambala) for the students admitted in the year 2007 onwards.

You are therefore requested to issue necessary notification at the earliest recognizing the Medical Qualification (MBBS) under Maharishi Markandeshwar University, Mullana (Ambala) which is already recognized under Kurukshetra University in respect of M.M. Institute of Medical Sciences & Research, Mullana, Ambala.
